Fund Factsheet

What is Kilgallioch Community Fund and who is it for?

Kilgallioch Community Fund is funded by ScottishPower Renewables community benefit funds, from its Kilgallioch Windfarm in Dumfries & Galloway and South Ayrshire.

The fund supports projects located within or directly benefiting Wigtownshire, Dumfries & Galloway and South Carrick, South Ayrshire. Projects must benefit one or more of the communities, which are geographically defined by community council boundaries. For eligible Community Council areas, please see the table below. How is Kilgallioch Community Fund managed, and who makes decisions about it?

Kilgallioch Community Benefit Company Ltd Board, which is made up of twelve local volunteer Directors, decides on grant awards from the fund. Administration is provided by Foundation Scotland, a national grant-making charity.

How much is available?

Approximately £1.2 million is available each year. Of this, 15% per community is distributed directly to Old Luce, New Luce, Kirkcowan and Barrhill for projects in those communities. 40% or around £475,000 is made available across the whole area of benefit, via this Kilgallioch Community Fund.

Who can apply for an award?

Applicants must normally fulfil the following conditions to apply to the fund:

- The proposal is for projects or activities consistent with the overall priorities and criteria of Kilgallioch

Community Fund;

- Applicants have a constitution (governing document or set of rules) and are set up on a not-for-private-profit basis. However groups do not need to be registered charities to apply.
- Applicants must provide their latest set of accounts, signed by an independent third party.

What sizes of awards are available?

- **Standard grants: £500 - £10,000.**
- **Large grants: over £10,000.** There is a two-stage application process for large grants. An initial one-page outline proposal in your own words is required. Please ensure you clearly state how much you are seeking, what it is for, your match funding plans, and the timescales for your project. The Board will review the proposal and agree whether to invite a full application. Proposals for 100% of project costs will not be considered.

What are the deadlines and timescales?

Due to anticipated high demand on the fund, the Board plans a single funding round in 2018/19, with the expectation all funds will be distributed in that round. The deadline for large grant proposals is 10th September 2018. Groups will be informed in early October 2018 whether they will be invited to continue to the next stage. The deadline for all applications is Monday 5th November 2018, for a decision in late February/ early March 2019.

What will Kilgallioch Community Fund support?

Kilgallioch Community Fund will support community-led charitable activities that support the rural regeneration and sustainability of communities in Wigtownshire and South Carrick.

Awards can support a wide range of costs and activities. Groups seeking to undertake capital projects in respect of land or assets (e.g. village halls, community spaces) must either own the property, or have a minimum ten-year lease. Due to high demand on the fund, ongoing running costs, although eligible, are less likely to be supported, as the Board will prioritise support for one-off or new projects.

Priority will also be given to applications that address one or more of the following aims:

- Engage and empower young people, increase employment opportunities for young people and/or attract young families to the area
- Reduce poverty and disadvantage
- Improve connectivity, including transport, access to services and opportunities
- Improve quality of life, health and well-being
- Build capacity for local groups and promote community spirit
- Build sustainable community assets, including capital assets.
- Promote, protect and celebrate natural and cultural heritage

What other criteria apply to the fund?

As well as demonstrating a fit with the aims outlined above, priority for awards may be given to projects that address the following additional criteria.

- **Community engagement and consultation:** That the applicant can demonstrate effective involvement of local people and/or people who will benefit from the project in the design and delivery of the project.
- **Leverage or match funding:** That the applicant is seeking to secure match funding for the project (from local fundraising activity or other sources) and/or can demonstrate what other funding may be secured as a result of implementing this particular project.

- **Local procurement:** That local suppliers of goods and services will be used, where appropriate (e.g., in terms of quality of products / services available) and feasible (in terms of availability and cost). The definition of 'local' will vary depending on the goods/services in question. In some cases it could be taken to mean within the Area of Benefit but in others the South of Scotland might be most appropriate.
- **Sustainability:** That organisations can demonstrate their plans for the project to become sustainable in the future without the need to rely on grant funding.
- **Building community capacity:** That the applicant has considered whether the project provides opportunities to build the skills and knowledge of group members or other people connected with the project.
- **Partnership working:** Where appropriate, that the applicant has considered whether delivering their project in partnership with other organisations / groups will add value (financial, capability, or other). This could involve working with voluntary, private or public sector bodies that operate at local, regional or national level.

What cannot be supported?

Awards cannot support the following types of activity:

- The advancement of religion or party politics (including requests to support the core activities of religious or political groups)
- Activities understood to be the primary responsibility of statutory authorities (including teaching equipment in schools).
- Projects benefiting primarily residents outwith the Area of Benefit (determined by the Community Council boundaries)
- Activities contrary to the interests of ScottishPower Renewables, Kilgallioch Community Benefit Company Ltd or Foundation Scotland, or likely to bring any of them into disrepute.
- Anti-renewable energy or anti-windfarm activities
- Retrospective funding (i.e. paying for costs incurred before a decision on an application to the fund for support can be made). If your project is time-sensitive, please contact us before applying.
- The repayment of loans or payment of debts.
- Individuals and groups that are not constituted
- Groups without a representative membership structure i.e. groups that unduly restrict their membership and/or where the committee or board is not elected by, or otherwise accountable to, a wider group of people.

How can I apply?

For standard grants, the simplest way is to apply online, via the fund web page www.kilgallioch.co.uk. Alternatively, application forms and guidance are available to download from the same page, or can be requested by email or post from the Programme Administrator at Foundation Scotland, on office@foundationscotland.org.uk or 01557 814927. Large grant proposals should be emailed to Foundation Scotland. A large grant application form will be provided to groups invited to apply.
